5. CHAIRMAN'S REPORT

"Since our last AGM on 10th October 2022, the project has taken another great leap forwards. We were delighted to welcome lain Russell onto the Board of Trustees, with his skills and expertise in the sustainable building sector. We also bade farewell to Kris Blood, who has been an invaluable member of the team, as a committee member of the Steering Group and latterly as a charity trustee, and our thanks go to her for her hard work in helping us to get to this point.

Fundraising events have been successful this year and, at year end (30th June), 80% of our local target of £50,000 had been raised. A very generous bequest was made to the charity from the

late Gary Cooper and this, along with other successful grant applications, has bolstered the reserves of the charity in readiness for commencing the main construction. Careful financial planning has resulted in two high interest accounts being opened for savings of £150,000 ensuring that the charity is earning additional sums whilst capital is not immediately required.

The Design Sub-committee has continued to ensure the hall design is tweaked and amended to be the best it can be. The appointment of Andrew Kirby Architects ensures professional support and guidance as the project moves towards the point of seeking tenders for the main build.

Since our Access Celebration event last September, the Hayes Field site has had significant further work completed – most of which has been undertaken by a volunteer workforce and free or hugely subsidised plant and machinery. The entire hall footprint has now been drained and levelled and the drainage swale has been created.

My thanks, as always, to my fellow Trustees for their tireless and dedicated work and to the numerous volunteers who are always there to support us and ensure that the provision of community facilities in Widecombe is secure for the future."
